1. I (the owner) confirm that I am the legal owner of the above listed pet(s) and I assume all risks, dangers, and responsibility for any injuries to the named pet(s).
2. I confirm that my pet is in general good health and that services rendered from Very Important Pets (V.I.P.) LLC may be denied if my pet is not.
3. I confirm that my pet(s) is free from any transmittable diseases, such as, but not limited to parvo, giardia, rabies, distemper, etc.
4. I confirm that my pet(s) is free from fleas, ticks, and other parasites.
5. I understand that I am solely responsible for the health and wellbeing of named pet(s) and acknowledge that I am responsible in keeping them up to date on vaccinations and other preventative care.
6. I confirm that my pet(s) is up to date on Rabies, Distemper, Bordetella (dogs), and Leukemia (cats) and that I may be denied services if I fail to provide proper documentation of the required vaccines.
7. I understand it is my responsibility to continually provide up to date information on my pet to Very Important Pets (V.I.P.) LLC in order to receive their services.
8. I understand that Very Important Pets (V.I.P.) LLC may terminate this contract for any reason without prior notice to me (the client).
9. I understand that normal play injuries may occur while named pet(s) are in the care of Very Important Pets (V.I.P.) LLC such as, but not limited to cuts, scratches, torn ligaments, broken bones, etc. I agree that Very Important Pets (V.I.P.) LLC is not liable for any injuries to named pet(s) sustained while at Very Important Pets (V.I.P.) LLC.
10. I understand that even though my dog is vaccinated for Bordetella/Kennel Cough that they may still contract the disease and acknowledge that Very Important Pets (V.I.P.) LLC is not liable for any treatment of the disease.
11. I understand that any dog(s) that pass the 4-hour evaluation and temperament test will be let out in groups and if I choose to have my dog(s) not partake in group play and potty, they will be let out alone, but the same fees and rates will still apply.
12. I understand that Very Important Pets (V.I.P.) LLC is not responsible for any lost items and any beds, blankets, toys, bowls, etc. that I bring for my pet(s) may not come home in the same condition as when I left it.
13. I agree to let Very Important Pets (V.I.P.) LLC use any photos or videos of my pet(s) in any form of advertising or social media posts. I relinquish all rights to claim such images and recordings as mine.
14. I understand that full payment is due at time of service.
15. I agree to keep an updated credit card on-file along with account information at Very Important Pets (V.I.P.) LLC.
16. I agree to give Very Important Pets (V.I.P.) LLC the ability to seek medical care from my regular veterinarian or any emergency veterinarian for any medical emergencies that may arise while my pet(s) are in their care. If in the event that

If this were to occur, I will not hold Very Important Pets (V.I.P.) LLC accountable for any wrongdoing and acknowledge that they gave my pet(s) the best care possible.

I understand and agree that each and every one of the foregoing provisions contained in paragraphs 1-18 shall be in full force and effect and shall apply to each and every occasion on which my pet(s) are at Very Important Pets (V.I.P.) LLC. This contract shall remain in full force and effect until and unless otherwise cancelled or suspended by Very Important Pets (V.I.P.) LLC.
